- The Government of India, on 20th September, 2019 vide the Taxation Laws (Amendment) Ordinance 2019, inserted a new section 115BAA in the Income Tax Act, 1961 which provides an option to the Company for paying income tax at reduced rates subject to compliance of the conditions stipulated therein. The Company has opted for the said section and accordingly computed tax expenses for three months and six months ended 30th September, 2019. The Company has also re-measured its Deferred Tax Liability resulting in reduction by ₹3,120 Lacs.
